## **Privacy Policy**

This Privacy Policy of Personal Data (hereinafter referred to as the Policy) applies to all personal data that the company LLC High Performance Computing Technologies (the " HPCT ") can receive from the User during the use of the official Run Parallel Site – <http://runparallel.net> (hereinafter referred to as the Site ), Use of Internet services, purchase of software services, participation in advertising and marketing campaigns or promotions and / or other interaction with HPCT (hereinafter - Services).

### 1. Definition of terms

1.1. In this Privacy Policy the following terms are used:

1.1.1. "Site Administration" - authorized employees on the site management, acting on behalf of LLC " HPCT ", who organize and (or) perform personal data processing, and also determine the purposes of personal data processing, the composition of personal data subject to processing, actions (operations) with personal data.

1.1.2. "Personal data" - any information relating to a person (legal entity) (directly or indirectly defined or determined by a personal data subject) directly or indirectly.

1.1.3. "Personal data processing" - any action (operation) or a set of actions (operations) performed by using automation tools (or without using such means) with personal data, including collection, recording, systematization, accumulation, storage, updating (updating, modification), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.

1.1.4. "Confidentiality of personal data" - mandatory requirement for the Site Administration or other persons who have access to a personal data to prevent the dissemination of personal data without the consent of the subject of personal data.

1.1.5. " Site User (hereinafter User) - a person who has access to the Site through the Internet and using the Run Parallel Site.

1.1.6. "Cookies" is a small piece of data sent by a web server and stored on a user's computer that the Web client or web browser sends to the web server each time in an HTTP request when it tries to open the page of the corresponding site.

1.1.7. "IP-address" is a unique network address of a node in a computer network built using the IP protocol.

## 2. General Provisions

2.1. HPCT does not control and is not responsible for third-party sites, which links are available on the Site. Third-party websites may have their own privacy policy and other personal information can be assemble or request from a user.

2.2. This Privacy Policy sets forth the obligations of the Site Administration not to disclose and to protect the personal data privacy, wich was provides by user, upon of the Site Administration request when the User has filling out the feedback form on the Site or in the process of using the Services.

2.3. Using the Services and providing HPCT with the information necessary to initiate further interaction, you agree that your personal information will be used in accordance with this Policy

2.4. For specific Services, HPCT may publish additional provisions supplementing this Policy.

## 3. Personal data of users wich are received and processed by HPCT

3.1. Within the framework of this Policy, "personal user data" means:

3.1.1. Personal data that can be used for independent work on the Site, or in the process of using the Services. The information required for providing (rendering) the Services is clearly indicated. Such information includes: a surname, a name and a patronymic, an e-mail address.

3.1.2 HPCT protects Data that is automatically transmitted when you visit the Site pages:

IP address;

Information from cookies;

Information about the browser;

Access time;

Referrer (address of the previous page).

3.2. The user's personal data which was provided to HPCT is deemed unreliable and may be blocked until the user or his legal representative will be consent to the processing of the user's personal data in any additionally designated form other than that provided on the Site.

#### 4. Objectives of processing user's personal information

4.1. HPCT handles only those personal data that are necessary to provide and improve the quality of the Services.

4.2. The user's personal information can be used for the following purposes:

4.2.1. Identification of the party as part of the provision of the Service.

4.2.2. Providing the user with personalized Services.

4.2.3. Improving the quality of services and developing new ones.

4.2.4. Conducting statistical and other studies based on impersonal data.

4.2.5. Provision of personal data to the right holders, distributors or software resellers for registering the software in the name of the user or organization whose interests the user represents.

4.2.6. Exercise and / or performance of functions, powers and duties imposed by the legislation of the Russian Federation at HPCT.

#### 5. Transfer of personal data to third parties

5.1. In respect of the user's personal data, confidentiality is reserved, except for the processing of personal data, which access was provided by the user to an unlimited number of persons, or at his request.

5.2. HPCT has all of the rights to transfer the personal information of the user to third parties in the following cases:

5.2.1. The user has given his consent to such actions, for the purpose of registering software for the user's name by right holders, distributors or software resellers.

5.2.2. The transfer is necessary to achieve the goals, implementation and performance of functions, powers and responsibilities imposed by the legislation of the Russian Federation at HPCT.

## 6. Measures applied to protect the personal data of users

6.1. HPCT takes necessary and sufficient organizational and technical measures to protect personal data from deferred or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions with personal data.

## 7. Rights and obligations of the user

7.1. Connective takes reasonable steps to maintain the accuracy and relevance of your personal data, as well as the removal of obsolete and other unreliable or superfluous personal data, however, the User is responsible for providing reliable information, as well as for updating the data provided of any changes

7.2. The user can at any time change (update, supplement) his personal information or a part of it, as well as the parameters of its use by contacting HPCT.

7.2.1. The user has all the rights at any time to withdraw consent to the processing of personal data by sending a notice to: 152934, Rybinsk, Yaroslavl Region, Karyakinskaya str, 50, office 5 in LLC " HPCT " with a note "withdrawal of consent to the processing of personal data." The user agrees that the user's consent to the processing of personal data entails the removal of all user personal data from the Site, as well as the destruction of records containing personal data in the personal data processing systems of HPCT, which may make it impossible to use HPCT 's Internet services.

7.3. The user has the right to receive information concerning the processing of his personal data in the HPCT, by sending a written request to the address: 152934, Rybinsk, Yaroslavl Region, Karyakinskaya str, 50, office 5, in LLC " HPCT ", with a note "request for information on the procedure for processing personal data."

7.4. HPCT may require that the identity of the user be confirmed by requesting the provision of such confirmation in any form that does not contradict the law, accordingly to clauses 7.2 and 7.3 of this Policy.

## 8. Settlement of Disputes

8.1. It is mandatory to file a claim (a written proposal for the voluntary settlement of the dispute), before applying to the court with a claim for disputes arising from the relationship between the Site User and the Site Administration.

8.2. The receiver of the claim shall notify the applicant in writing of the claim about the results of the examination of the claim within 30 calendar days from the date of receipt of the claim

8.3. If the agreement is not reached, the dispute will be referred to the judicial authority in accordance with the current legislation of the Russian Federation.

8.4. The current legislation of the Russian Federation applies to this Privacy Policy and the relationship between the User and the Site Administration.

## 9. Additional conditions

9.1. The site administration has all the rights to make changes to this Privacy Policy without the consent of the User.

9.2. The new Privacy Policy comes into effect from the moment it is posted on the Site, unless otherwise provided for in the new edition of the Privacy Policy
